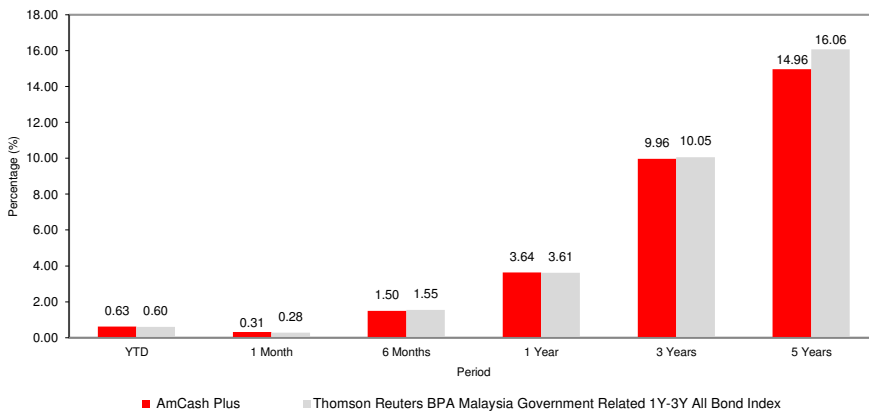

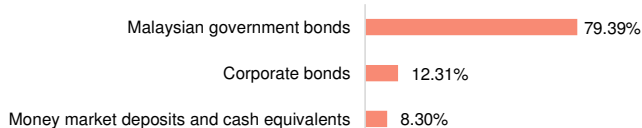

## Asset Allocation (as at 28 February 2025)



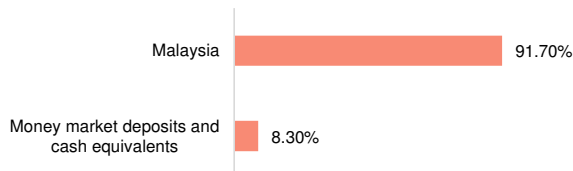
