### Investment Objective

AmlIncome Institutional\* SRI 3 (formerly known as AmlIncome Institutional 3) (the "Fund") is a fixed income fund which aims to provide a stream of income\*\* and to a lesser extent capital appreciation.

\*Institutional refers to the potential sophisticated investors of the Fund and not to the nature of the investables.

- regular income\*\*.

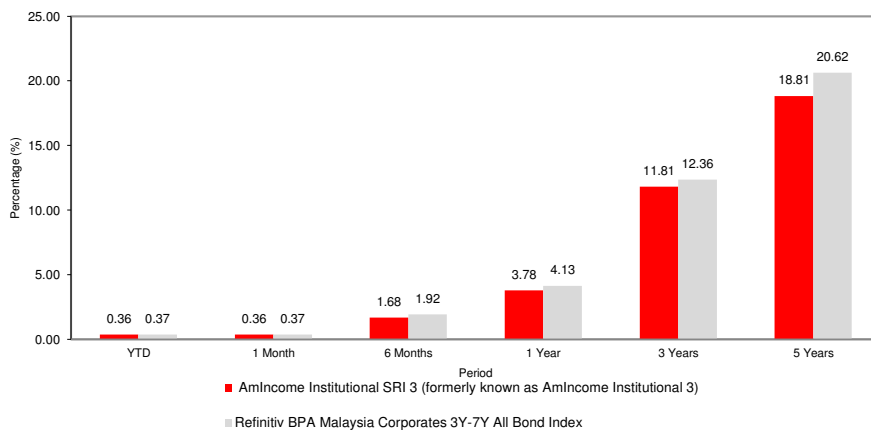

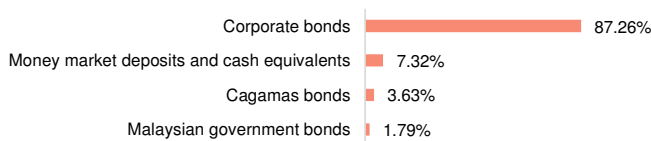

## Asset Allocation (as at 31 January 2025)



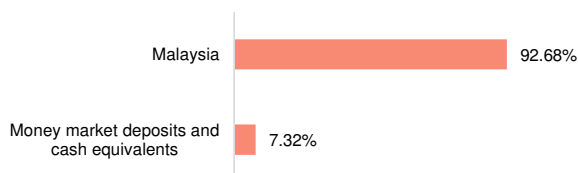
