Amlslamic Global SRI (RM Class) (the "Fund") aims to provide total return that outperforms its benchmark over medium to long-term* by investing in Shariah-compliant equities of companies incorporated and/or primarily listed in developed countries.

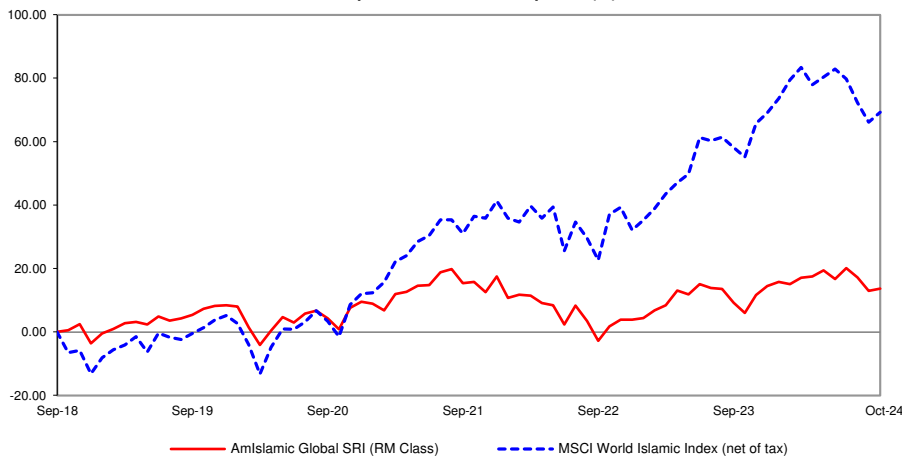
The Fund is suitable for investors seeking:

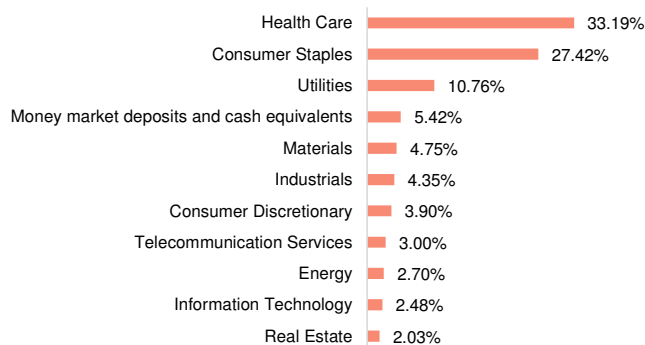

Sector Allocation (as at 31 October 2024)



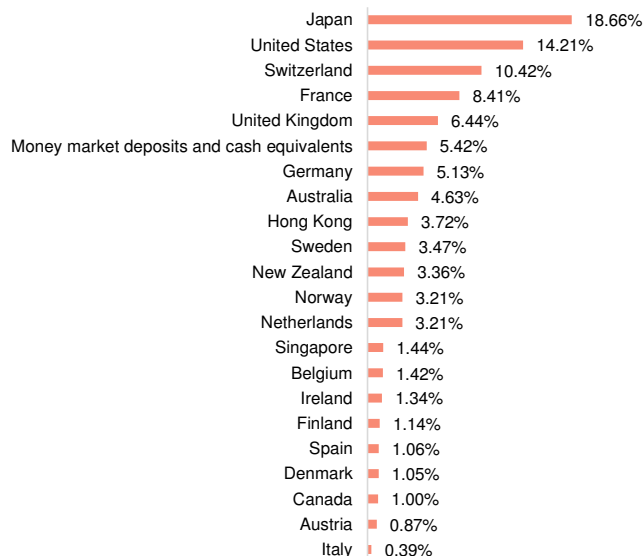
