
AmPRS - Conservative Fund (the "Fund") aims to preserve* capital by investing primarily in fixed income securities and money market instruments.



This stability in interest rates is anticipated to support the bond market, as it reduces uncertainty and volatility. We will configurate the portfolios at a slight overweight in duration against benchmark while identifying bonds along the yield curve that are undervalued compared to their peers.
